- The reporting person also directly owns employee stock options to purchase (I) 143 shares of the Company's common stock at \$39.53 per share which became exercisable in three equal annual installments beginning on January 28, 2000 and expiring on January 28, 2009 and (II) 155 shares of the Company's common stock at \$46.625 per share which became exercisable in three equal annual installments beginning on January 24, 2003 and expiring on January 24, 2012.
