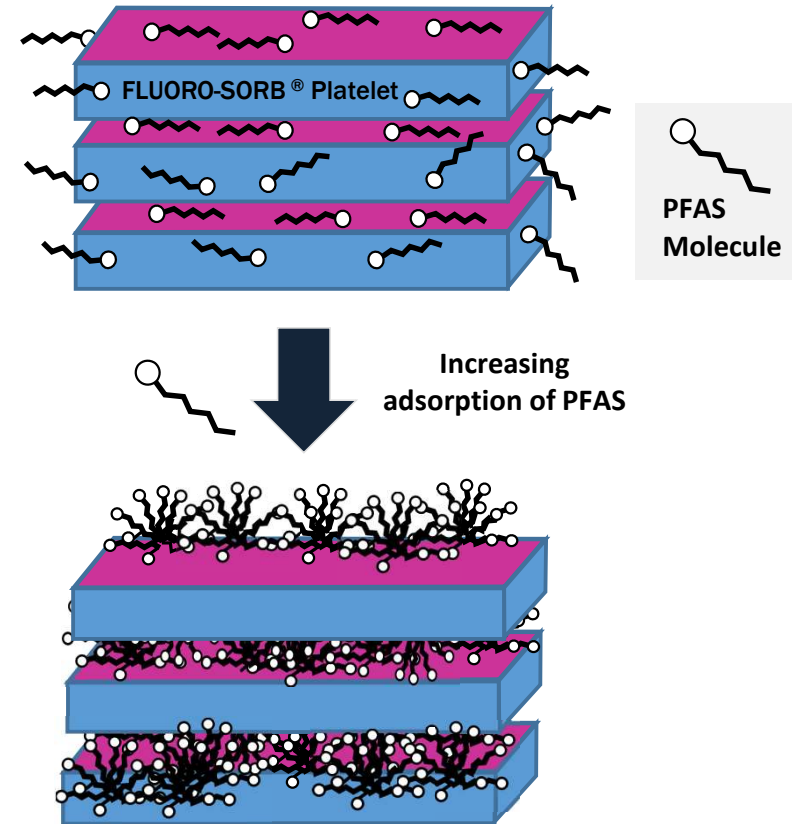
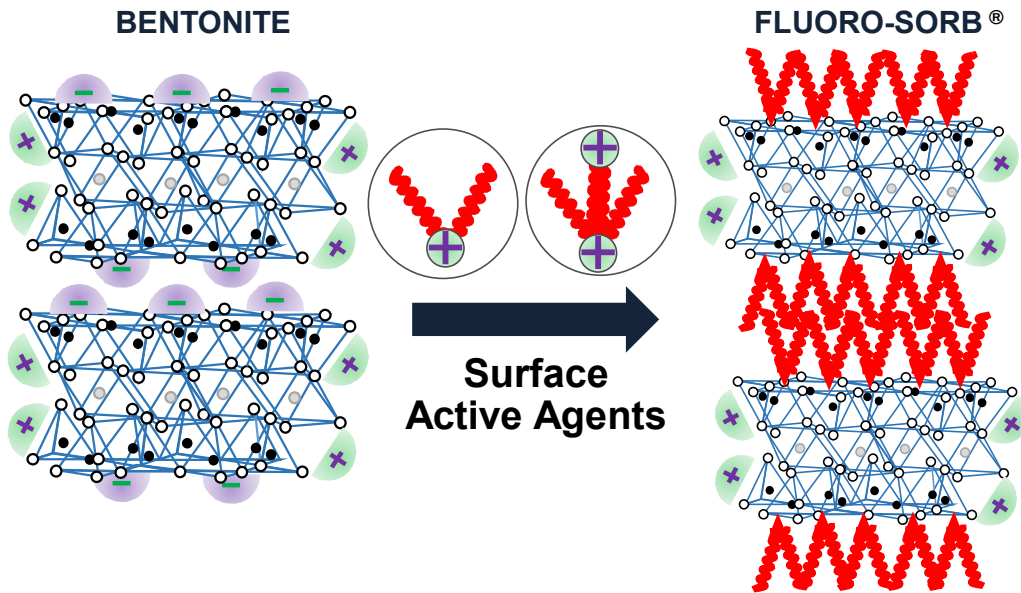


Unique bentonite properties:

- Platelets have very high surface area (800 m²/gram)
- Platelet surface is negatively charged – edges are positively charged



PFAS Adsorption Mechanism

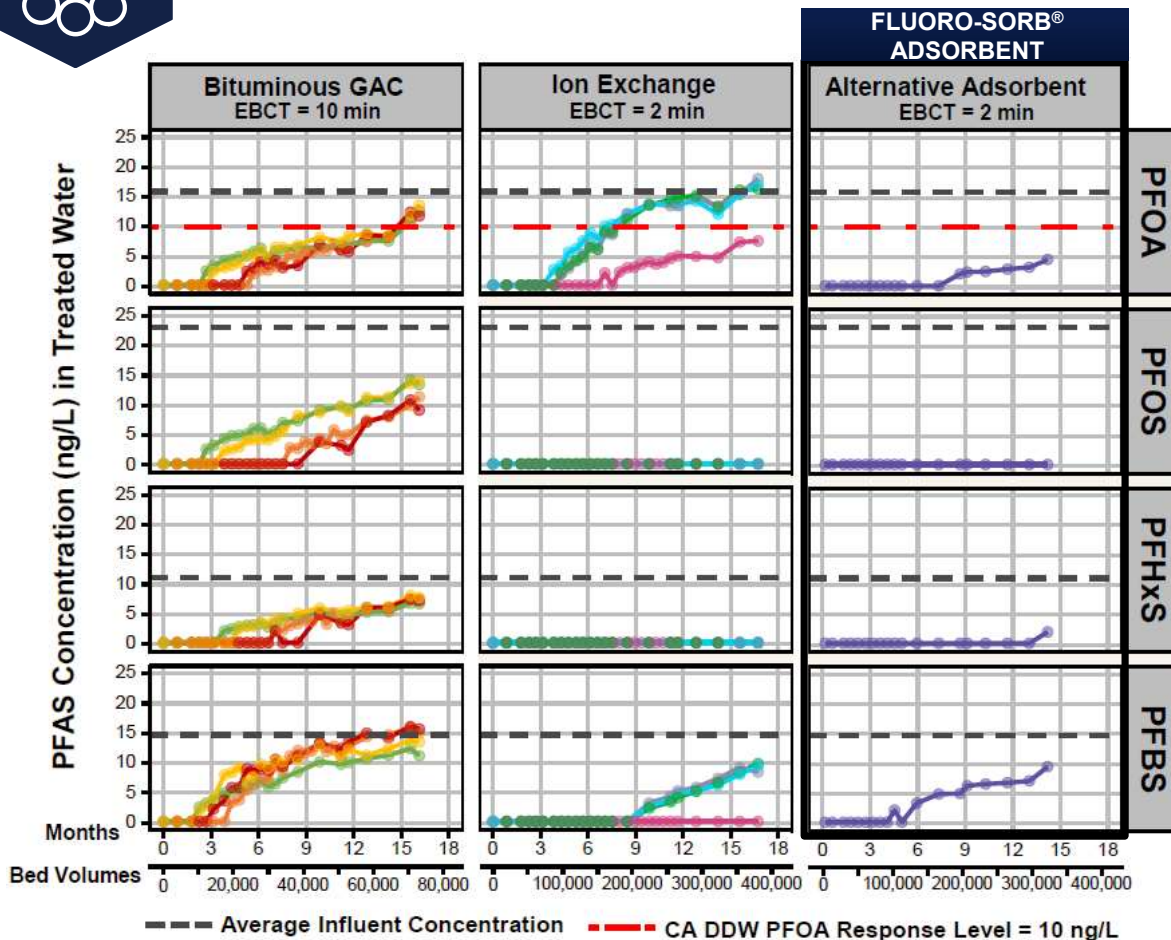

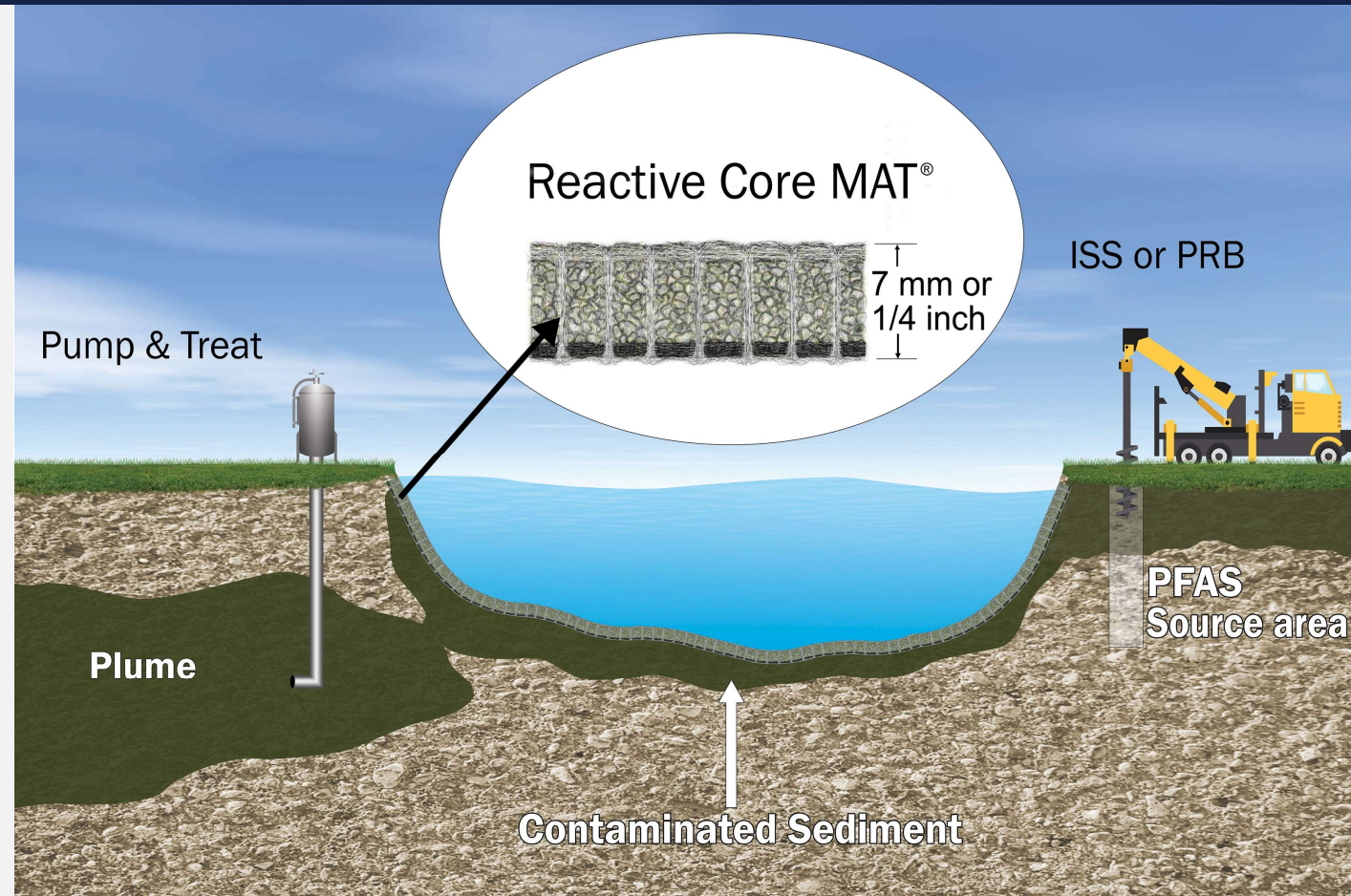

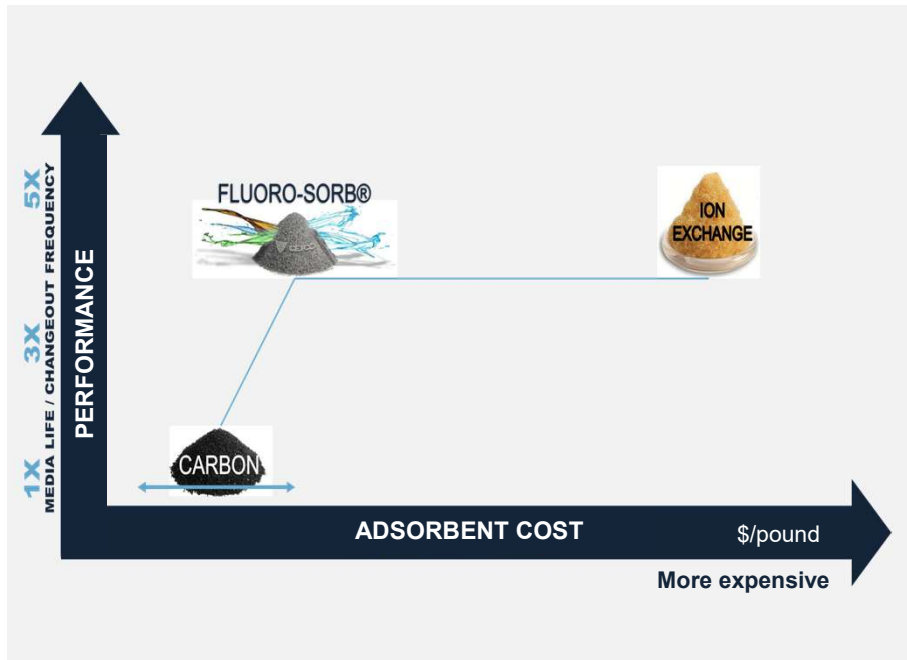
